Scope

Welcome to Push's Privacy Policy. Your right to privacy and online security is important. This Privacy Policy describes Push Inc.'s collection, protection, disclosure, and use of your information. This Privacy Policy applies to all of Push's websites, mobile applications, and/or online services, that link to or reference this Privacy Policy. It covers your personal information that is provided or collected through the use of our services and how we use that information in connection with our services.

By using Push, you agree to this Privacy Policy. If you do not agree with any term in this Privacy Policy, please do not use our services.

Quick Overview

Push is designed to help you manage and track group expenses. Expenses you add in Push are not public. Friends who are included on an expense can view that expense, and, if an expense is added in a group, other group members can view expenses shared on Push. You choose who you share your expenses with and what kind of expenses you want to share.

To use Push, we require you to sign in with Google. When you sign up, we'll request access to your Google account information, such as your name, email address, and profile picture. We are using and storing only your email address.

In addition to sharing your registration information to set up your account, we collect some other information about you, such as the type of device you use and your IP address. We may also collect information about the type of expenses you add, or the groups you create. We use this information to help improve and secure our service.

You have control over the type of information you provide and how we use it. We don't share your registration or personal information for marketing purposes. We will never share your information with other parties for use other than what's laid out in this policy without your consent. If you have any questions please contact us at support@push-app.ru

Push or its partners or service providers may maintain operations in the United States or any other country, and therefore your personal information may be processed outside the country where you are located. By using and providing information to us, you agree and consent to the transfer, storage, and processing of your information in other countries. Countries that we transfer your information to may not have data protection laws similar to those of where you are located.

Push is not intended for use by children under 13 years of age or minors. We do not knowingly collect personally identifiable information from children under 13. If a parent or guardian becomes aware that their child has provided us with Personal Information without their consent, they should contact us at support@push-app.ru. If we become aware that a child under 13 has provided us with Personal Information, we will delete such information from our files immediately.

Data We Collect

When you use Push, we may collect the following information about you:

Information you provide to us:

Registration information:

To use Push, we require you to sign in with Google. When you sign up, we'll request access to your Google account information, such as your name, email address, and profile picture. We are using and storing only your email address.

User-generated content

We also collect and store the information you provide to us when using our service to share expenses, payments. This data includes, for example, group names, expense descriptions and amounts, comments and reminders, receipt images, notes, and memos, in addition to any other information that you attach or share while using Push. You may share this information with contacts you specify in the course of using the Service. For example, if you add an expense with a group of friends, those friends will be able to see that expense, while users who are not part of the group will not. You are solely responsible for which contacts you share this information with.

User-generated invitations / Adding users to a group

Invitations to a specifically chosen friend or set-of-friends to join Push in general, or a specific relationship or group, can be sent at your request on your behalf. When you invite a friend or contact to Push, we use only a QR code or a generated link. No other information is collected or used for invitations. A few messages will be sent to these contacts through the chosen communication channel, or a link will be provided for you to send the invitation yourself. Your name, the contact name, and the name of the associated group may also be incorporated in invitation messages sent by Push, as applicable.

Information we collect automatically

Device and Location information

When you download or use Push, we may receive information about your device, which allows us to provide increased account security and regulatory compliance. We do not use user location information in the application. However, third-party services we employ for data analytics may collect anonymized location data. We also collect information about your interaction with Push, including, but not limited to, average time spent on our sites, your IP address, unique identifiers of your device, the operating system version, and app version.

How We Use Data

****We use your information for the following purposes:**

To Provide the Push Service

Push is designed to help people share expenses and informal IOUs with friends. We process your information to provide, support, and secure our service (both automatically and manually). For example, we may use your information in some of the following ways:

- To record informal records of expenses, IOUs.

- To fulfill your requests for certain products and services.
- To detect and protect against errors.
- To analyze Site usage, perform market research, project planning, product development, troubleshooting problems, analysis of user behavior, internal marketing and promotions, or other efforts to improve our service quality.
- To alert you to software compatibility issues and to improve our app design and functionality.
- To communicate with you. For example, we will email you when we release new features, have important news, and when you have a notification generated by activity. Some emails, such as updates to our Privacy Policy, information about your account, password resets, or other security issues are not optional.
- To enforce our Terms of Service.

****How We Share Your Information**

We will not, without your permission, sell, publish, or share your personal information to third parties for their marketing purposes. We will not sell, publish or share the personal information you provided for the purpose of sending user-generated invitations to third parties for their marketing purposes.

To Provide the Push Service

Push is designed to help you track and share expenses with your friends. We share some of your personal information (name, user avatar) with your friends and groupmates on Push.

- Push allows you to keep track of expenses in groups. These groups are private, and information and expenses posted in a group are only visible to other members of the group. However, any user in that group may add additional members to the group, so it is the joint and sole responsibility of group members to safeguard who they invite into their group sharing platform.
- Push lets friends add, edit, delete and undelete content shared privately.

-In Push, users can only see their own debts and the debts owed to them by others. The debts of other group members are not disclosed. This ensures that each user has access only to the relevant information, maintaining privacy within the group.
